**RESOLUTION #2362018
AWARD BID FOR 2019 TOWN STREET SWEEPING AND CATCH BASIN
CLEANING SERVICES**

The following Resolution was offered by Councilwoman Meunier, seconded by Deputy Supervisor House, to wit:

WHEREAS, the Town of Dover Highway Superintendent is in need of equipment to provide street sweeping and catch basin cleaning for the Town of Dover roads and has sought bids for said services.

WHEREAS, the Highway Superintendent has recommended that Custom Street Services, LLC was the lowest responsible bidder for street sweeping with the necessary equipment of waterless dual broom mechanical street sweeper with Dry Dust Control with a high dump minimum of 10 feet be contracted with to provide a street sweeper/vacuum to the Town for an hourly rate of \$130.00 per hour and \$1,040.00 per day; and Custom Street Services, LLC to be contacted with to provide equipment for the cleaning of catch basins at an hourly rate of \$150.00 per hour and \$1,200.00 per day, which was the lowest responsible bidder.

NOW THEREFORE BE IT RESOLVED, that the Town Board of the Town of Dover hereby authorizes the Town Supervisor to sign the proposals of Custom Street Services, LLC of Hyde Park, New York, subject to verification of necessary and required liability insurance certificates.


The Resolution was thereupon adopted on December 19, 2018.
