3) The applicant may request an itemized estimated bill of service	
4) Fees are as follows:	
a) Negative declaration	\$500.00
When the account gets to \$250.00, it is to be replenished to the amount of \$500.00	
b) Positive declaration: \$1,000.00 for the first lot and \$500 for each additional lot, to a maximum of \$10,000. When this account falls to 50% of the original escrow, it must be replenished to the original amount until the project receives final approval. Escrow will be set by reviewing board.	
c) The balance of the escrow will be refunded 90 days after final approval is given or when all bills pertaining to the project have been paid.	
d) Site plan: \$500.00 minimum to \$10,000.00 maximum, at the discretion of the Planning Board or other Board of Review. Or at the request of the applicant, the Planning Board or other Board of Review may obtain an estimated bill of services with the escrow to be set at the estimate, plus 10%.	

The Planning Board, or other Board of review, will respond to the applicant 30 days after the request of an estimate.
