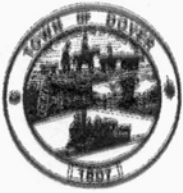


The Resolution was thereupon adopted on April 25, 2018.
